**Political Action Committees**

This section summarizes how Political Action Committees (or PAC's) were financed during the 2010 State and Local Elections. The information was obtained from the Campaign Statements (NADC Form B-4) filed by the Political Action Committees.

The Statewide Primary Elections were held on May 11, 2010 and the Statewide General Elections were held on November 2, 2010. Special Elections for some ballot issues were also held on other dates.

In the summary, "Receipts" refers to the net total of all receipts from all sources during the election year and "Expenditures" refers to the net total of all expenditures during the election year.

"Nebraska Expenditures" are disbursements made in support of or in opposition to Nebraska state and local candidates and ballot questions.
