#### **Candidates and Ballot Questions**

This section summarizes how candidate and ballot question committees were financed during the 2012 State and Local Elections. The information was obtained from the Campaign Statements (NADC Form B-1) filed by the candidates and ballot question committees.

The Statewide Primary Elections were held on May 15, 2012 and the Statewide General Elections were held on November 6, 2012. Special Elections were held on March 3, 2012 (Chadron) and September 11, 2012 (Omaha District 66).

In the summary, “Annuals” refers to annual campaign statements filed leading up and prior to the 2012 election year. “Primary” refers to campaign statements filed for the primary election. “General” refers to campaign statements filed for the general election. “Receipts from Others” includes contributions from Businesses, PAC’s, and Political Parties. “Receipts from All Sources” also may include loans received or repaid and bank interest. “Won or Lost” next to Primary or General designates if the candidate won or lost the primary or general election.

Formation of a political committee is required upon raising, receiving or spending, more than \$5,000 within a calendar year to influence an election. Therefore, some candidates had no committees and some offices or ballot issues that appeared on the ballot may not be listed in this summary.
